- d. Aadhar card of Applicant
- e. Aadhar card of the Student
- f. Ration card /Food Security card/Income certificate
- g. A letter from applicant explaining the financial and family

- condition, if felt necessary by the Member who recommends the case
- h. Recommendation of the Member recorded on the Application

**B. Financial assistance to meet Medical expenses**

- a. Application duly filled in
- b. Estimate of expenditure from the Hospital
- c. Copies of treatment papers giving diagnosis, test reports etc
- d. Arogya Sri Card in r/o cases from Andhra Pradesh and Telangana and any such card of health schemes in respect of other states
- e. Certificate from the Hospital whether the ailment is covered under Arogya Sri / other schemes  
and if not covered confirming the same.
- f. If the patient is treated in a hospital not empanelled under Arogyasri/ other schemes , a letter from the applicant explaining the reasons for the same
- g. Aadhar card of the Applicant
- h. Aadhar card of the patient
- i. Ration card/Food Security card/Income certificate
- j. Recommendation of the Member recorded on the Application
- k. A letter from applicant explaining the financial and family condition, if felt necessary by the Member who recommends the case.
