2. Financial Assistance for Educational Assistance

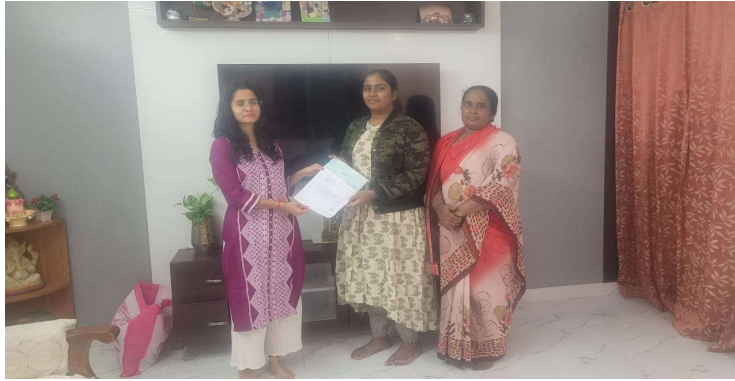
